UP: WINE AND GRAPE JUICE - MEVUSHAL?

DAF NOTES:

The OU maintains the position of the Igros Moshe that heating grape juice or wine to 175° F renders the product Mevushal and thereby permissible to be handled by non-Jews.

All wine products bearing the OU symbol indicating Mevushal have been heated to a minimum 175° F.

All OU grape juice is pasteurized at a minimum 175° F. The only exception to this rule is the Kedem 1.5 liter glass grape juice whose label clearly states "not Mevushal." This product is pasteurized at lower temperatures.

There are other opinions requiring higher temperatures. The OU does not follow these.

The position of the OU Poskim is that, although there is a Hidur to use non-mevushal wine for Mitzva purposes (Kiddush, Seder Cups), mevushal wine may still be used lechatchila.

MEDICINES AND INEDIBLES

Guidelines for Medicines on Pesach

The following are guidelines for the use of medication on Pesach for individuals who are ill:

- Creams, non-chewable pills and injections may be owned and used on Pesach even if they contain chametz, since they are inedible. This covers most medicines used by adults.
 - a. It is permissible to grind pills and mix the powder into food items so that a child can take medicine on Pesach. However, a doctor <u>must</u> be consulted to make sure that the child is getting the correct dosage and that the potency of the pill is not compromised by grinding it up.

If an equally effective chametz-free alternative is available, it should be used.

- Liquid medicines, chewable pills (and pills coated with a flavored glaze) are edible and may contain chametz. Therefore:
 - a. If possible, they should be replaced under the direction of a doctor with a non-chewable, uncoated pill.
 - b. If substitution is not possible and the person is in a state of *sakanah* or *safek sakanah* (any possible danger to human life), they may own and consume the medication. The same applies if the condition is not yet a *safek sakanah* but may deteriorate to that point.
 - A Rabbi should be consulted as to whether it is preferable to purchase the medicine before or on Pesach, and as to how to dispose of the medicine once the danger passes.
 - c. If substitution is not possible and a doctor determines that there is no possibility of *sakanah* if the person doesn't take the medicine, a Rabbi should be consulted. He may be able to determine that the medicine does not contain chametz or he may decide that the medicine may be consumed due to the seriousness of the patient's condition.

LO BOSI ELA L'ORER

Kashering a Kli that was used for Kitniyos

The *Rema* (453:1) paskens for Ashkenazim that if kitniyos falls into food and it is *batel b'rov* in the *ta'aroves*, the food may be eaten on Pesach. For example, if a small amount of corn oil falls into a food and is *batel b'rov* the food may be eaten. In such a situation, the *kailim* may be used for a pesach production without kashering.

What is the halacha regarding a *kli* that had been used to produce corn oil or some other form of kitniyos? Would the food subsequently produced in the *kli* be kosher l'pesach? The halacha is that we can assume that the *b'lios* of corn oil will always be *batel b'rov* in the future productions and any food produced in those kailim may be eaten on Pesach.

The more complicated question is, may such a *kli* be used *l'chatchila* for pesach without kashering? Many poskim assume that if the *kli* is *ben yomo* it should not be used for pesach without kashering. They assume that it is inappropriate to use a *klii ben yomo* that is *balua* with *issur* even if that *issur* will always be *batel* in the future uses of the *kli*. This would be considered a form of *bitul issur l'chatchila* (see *Kaf Ha'chaim*, *Orach Chaim* 453:27).

What if the *kli* is *aino ben yomo*, would the halacha be the same? Most poskim agree that if the *kli* is *aino ben yomo* from a kitniyos production it may be used for pesach without a kashering. Two different explanations are given for this psak:

- 1. The *gezeira d'rabanan* of not using a *kli she'aino ben yomo* is because one may come to use the *kli* when it is a *ben yomo*. In this situation, where the issur will be *batel b'rov* even when the *kli* is *ben yomo*, the *gezeira* does not apply.
- 2. The *gezeira d'rabanan* of not using a *kli she'aino ben yomo* does not apply to kitniyos, which is only a minhag (based upon *Shach Yoreh Death* 119:20).

The policy of the OU is that if the *kli* that was used for kitniyos is *ben yomo*, it should not be used for pesach without kashering. If the *kli* is *aino ben yomo*, *mei'ikar ha'din* it may be used without kashering. Nonetheless, whenever feasible we make every effort to kasher [Document P-76].

THE HALACHIC ADVENTURE CONTINUES...

UNDERSTANDING SHMURAH MATZAH

The Gemara in Pesachim (40a) comments on the pasuk (ריי, "שמרתם את המצות (שמות "יב, "יי) that there is a special mizvah of shemira on the matzos which are eaten on Pesach. Most Rishonim understand that there is a special mitzvah to watch and protect the grain and flour used for baking of the matzos l'shaim mitzvas matzah. Even if the grain is stored and protected in a manner that ordinarily there would be no concern of the grains coming in contact with water and becoming chametz, nevertheless, there is a mitzvah to guard the grain l'shaim mitzvas matzah.

When must one begin watching or guarding the grains that are

used in baking the pesach matzos *l'shaim matzos mitz-vah?* There are three opinions in the Rishonim whether the *shemira* must be done from the *ketzirah* (harvest), *techinah* (grinding), or the *lishah* (kneading). The Shulchan Aruch (452:4) says that preferably one should use grain that was guarded from the *ketzirah* and *b'shas ha'dchak* one is *yotzai* if it was watched only from the *lishah*. It should be noted that even according to the latter, more lenient opinion, one must be sure that the grain never becomes chametz. If the whole grain or flour is washed or soaked in water before the matzah is baked, as

is common in regular flour production, it may become chametz.

Does one have to eat Shemura Matzah all eight days of Pesach or only at the seder? Most Rishonim understand that the mitzvah to eat shmura matzah specifically applies on the first night of Pesach

- In many cases, medicinal items which contain kitniyos are permitted for people who are ill. Questions on this issue should be directed to your local Rabbi.
- People should exercise extreme caution and consult with their doctor and Rabbi before making a decision to <u>not</u> take a medicine.
- 5. These guidelines do not address the question of consuming medicines on Shabbat and Yom Tov.

Inedibles on Pesach

The following household items may be used on Passover without certification, as they either contain no chametz, or any chametz in them would be *nifsal* (rendered inedible):

> in fulfillment of the mitzvah of בערב תאכלו מצות (שמות "יב, "יח). Therefore, the rest of Pesach one may eat non-shmurah matzah.

Water filters

However, the *Magid Mishnah* explains that according to the Rambam (*Hilchos Chametz U'matzah* 5:9) the mitzvah of *shimur* is relevant to the matzah that is eaten throughout the holiday of Pesach and if possible one should try to eat shmurah matzah all eight days. The accepted custom is to follow the former opinion that the obligation to eat shmura matzah is only on the matzah eaten at the seder. However, there are those who are *machmir* and have accepted upon themselves to eat only shmurah matzah all eight days of Pesach (see *Sharei Teshuva* 453:8 and *Nefesh Ha'rav* pg. 189).

There are many Jews who are not aware of the requirement to eat shmura matzah on the first night of Peasch and eat regular machine matzah at the seder. In order to accommodate such people, all of the machines which knead and bake matzah that are produced by Manishewitz are started *l'shaim mitzvas matzah*. Since there are some opinions that hold that shmurah matzah can be made with a machine and the Shulchan Aruch rules that *b'shas ha'dchak* one can fulfill the mitzvah of eating matzah even if the *shmirah* was only from the time of kneading, one who eats such matzah will have fulfilled the requirement of eating matzah shmurah according to some opinions.
